



Initial review criteria

1. Topic consistent with the journal's scope
2. Cover letter with the institution's letterhead with the handwritten signature of the corresponding author
3. Front page according to the Guide for authors
4. Maximum length according to the Guide for authors:
 - 4 500 words for scientific articles
 - 3 500 words for scientific or technological notes
 - 6 000 words for review articles
5. Tahoma font, size 12, and 1.5 line spacing
6. Margins of 2.5 cm on all four sides
7. Page numbering in the lower right margin
8. Continuous line numbering along the left margin, except for tables and figures
9. Title with a maximum of 15 words
10. Names (scientific, active ingredients, among others) according to the Guide for authors
11. Abstract structured in sections: introduction, objectives, methodology, results, limitations of the study, originality, and conclusions
 - 250 words for scientific articles and reviews
 - 150 words for scientific or technical notes
12. Keywords according to subject matter and the Guide for authors
13. Tables created using the word processor's table editor, formatted according to the Guide for authors
14. Equations created using Word's equation editor
15. No equations have been inserted to display symbols or variables in the manuscript (use the insert symbol tool and apply italic formatting to variables).
16. Images with a resolution of at least 600 ppi, minimum size of 945 x 945 pixels, in JPG or TIFF format
17. Figures, graphs, and flowcharts must be included as images, not as objects, as indicated in the Guide for authors
18. Tables and figures must be self-explanatory
19. Figures must not duplicate the information presented in tables
20. Measurement units must follow the International System of Units



21. Provide the model, brand, and country of origin of the measurement equipment used
22. Consistency between the title, objectives, and conclusions, in accordance with the scope of the research
23. Objectives must clearly reflect what the research is about, how it is conducted, and its purpose
24. Objectives must be identical in both the abstract and the introduction
25. Detailed description of factors, treatments, experimental or sampling units, and statistical analysis
26. Detailed description of how response variables are recorded, including measurement units
27. Declared differences supported by appropriate statistical tests
28. The conclusions are drawn from the discussion and do not simply repeat the results
29. Conclusions limited to a maximum of 150 words
30. Avoid over-citation of a single idea: the individual contribution of each cited source must be indicated
31. References presented in APA 7 format
32. All references include a DOI or, if not available, the URL where they can be accessed
33. Cited references in the text are included in the reference list (and vice versa)
34. No citations from theses, symposiums, congresses, seminars, school manuals, interviews, news articles, or research project reports
35. Current references: over 80 % less than 10 years old
36. No field codes in references (remove field codes):

38. Fluid writing, with paragraphs no longer than 10 lines
